As a standard or express retail center franchisee, you will sell business support, mailbox, postal, printing, copying, packaging, shipping, office supply, passport photo, notary and related products and services. As a flex retail center franchisee, you will sell some of the services of a standard or express retail center, as well as crating, pick-up and delivery services and boxes and packaging materials. As a copy retail center franchisee, you will sell business support, postal, packaging, shipping, office supply, personalized mailing, direct mail, digital printing, copying, offset printing, large-format printing, binding, finishing, graphic design and related products and services
