The franchise offered is for the right to operate a hotel that provides lodging services to the public under the names "Park Inn® or "Park Inn by Radisson" (collectively referred to in this document as "Park Inn®" or the "Park Inn System").

The total investment necessary to begin operation of a 200-room Hotel with food and beverage ranges from \$1,684,080 to \$4,791,260. This includes \$50,320 to \$117,770 that must be paid to the franchisor or its affiliates, but excludes the cost of real estate.

This Disclosure Document summarizes certain provisions of your License Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale or grant. **Note, however, that no government agency has verified the information contained in this document.**
