

This franchise is a business offering children's education, recreation and entertainment interactive enrichment activities using our system and our trademark "Parker-Anderson Enrichment"

The total investment necessary to start operation of a Parker-Anderson business is \$32,380-\$64,600 for a new Parker-Anderson business and \$208,040 to \$534,700 if you buy an existing business from us or our affiliate. This includes \$22,000 to \$29,900 that must be paid to the franchisor for a new Parker-Anderson business and \$200,000 to \$500,000 that must be paid to the franchisor if you purchase an existing business from us or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
