The Franchise offered is for the establishment and operation of Patinella's Chicken Grill restaurant, a fresh healthy approach to grilled chicken cuisine in a casual and warm atmosphere.

The total investment to begin operation of a Patinella's Chicken Grill restaurant franchise is from \$293,750 to \$460,000. This includes \$25,000 that must be paid to the Franchisor and affiliate.
