The franchise offered is to own and operate a business providing pet cremation and memorialization products and services under the "Paws & Remember®" name

The total investment necessary to begin operation of a Paws & Remember Business ranges from \$176,500 to \$430,000 (excluding real estate costs) to develop a new facility and from \$35,000 to \$273,000 (excluding real estate costs) if you operate a similar business. This includes \$21,000 to \$24,000 that must be paid to the franchisor or an affiliate
