As a franchisee you will operate a facility which provides specialized health care and educational services for children with special needs, developmental delays and learning differences under the trademark PEDIATRICS PLUS featuring specialty classrooms, therapy, pre-school, family support and care coordination and psycho-educational evaluations authorized by us.

The total investment necessary to begin operation of a PEDIATRICS PLUS facility is \$655,000 to \$1,140,000. This includes \$50,000 that must be paid to the franchisor or its affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

YOU MAY HAVE TO SIGN A NEW AGREEMENT WITH DIFFERENT TERMS AND CONDITIONS IN ORDER TO CONTINUE TO OPERATE YOUR BUSINESS. BEFORE YOU BUY, CONSIDER WHAT RIGHTS YOU HAVE TO RENEW YOUR FRANCHISE, IF ANY, AND WHAT TERMS YOU MIGHT HAVE TO ACCEPT IN ORDER TO RENEW.

Please consider the following RISK FACTORS before you buy this franchise:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO ARBITRATE WITH US ONLY IN THE OFFICE OF THE AMERICAN ARBITRATION ASSOCIATION CLOSEST TO OUR PRINCIPAL EXECUTIVE OFFICE. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT ALSO MAY COST YOU MORE TO ARBITRATE WITH US WHERE OUR PRINCIPAL EXECUTIVE OFFICE IS LOCATED THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT ARKANSAS LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFIT AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. PEDIATRICS PLUS FRANCHISING, INC. WAS INCORPORATED ON APRIL 30, 2014, AND HAS NO HISTORY IN FRANCHISING. THE INITIAL FRANCHISE FEE REQUIRED TO BUY THIS FRANCHISE EXCEEDS FRANCHISOR'S EQUITY IN THE COMPANY.
- 4. WE DO NOT DIRECTLY CONTROL REIMBURSEMENT RATES FOR SERVICES WE BILL TO GOVERNMENT PROGRAMS AND PRIVATE INSURANCE. SUBSTANTIALLY ALL OF THE REVENUE WE GENERATE FROM THERAPY SERVICES IS FUNDED THROUGH REIMBURSEMENTS FROM PRIVATE INSURANCE COMPANIES AND STATE GOVERNMENT PROGRAMS SUCH AS MEDICAID. IN ADDITION, PRESCHOOL TUITION MAY BE FUNDED THROUGH GOVERNMENT PROGRAMS. THESE RATES MAY CHANGE SUBSTANTIALLY WITHOUT PRIOR NOTICE. REDUCTION OF REIMBURSEMENT RATES COULD HAVE A MATERIAL ADVERSE EFFECT ON OUR BUSINESS.
- 5. YOUR THERAPY AND PRESCHOOL SERVICES WILL REQUIRE A SIGNIFICANT INVESTMENT IN REAL ESTATE AND EQUIPMENT, WHICH MAY NOT BE RECOVERED IF THE FRANCHISE IS NOT SUCCESSFUL.
- 6. DELAYS IN REIMBURSEMENT MAY CAUSE WORKING CAPITAL AND LIQUIDITY PROBLEMS. YOU MAY EXPERIENCE DELAYS IN RECEIVING REIMBURSEMENTS FOR SERVICES, ESPECIALLY FROM PRIVATE INSURANCE AND GOVERNMENT

PROGRAMS. THESE DELAYS MAY STEM FROM CHANGES IN REIMBURSEMENT POLICIES, REQUESTS FOR ADDITIONAL DOCUMENTATION, BILLING SYSTEM CONTROLS AND CONVERSIONS, CHANGES IN GOVERNMENT FUNDING AND OTHER ISSUES. DELAYS IN RECEIVING REIMBURSEMENTS FOR YOUR SERVICES WOULD HAVE A SIGNIFICANT ADVERSE EFFECT ON YOUR CASH FLOW.
