We offer two types of franchises: 1) Pelindaba location franchises (referred to hereafter as “a Pelindaba Location franchise” or “Location(s)"); and 2) Pelindaba regional developer franchises (referred to as “a Pelindaba Regional Developer” or “Regional Developer(s)"). We are offering the right to operate a Pelindaba Location franchise under this Disclosure Document. Pelindaba Lavender Regional Developer franchises are offered under our separate disclosure document for Regional Developers (“FDD for Regional Developers”).

The total investment necessary to begin operation of a Pelindaba Location franchise ranges from **\$116,040 to \$202,750**. The total investment includes an initial franchise fee of **\$35,000** that must be paid to the franchisor or an affiliate.

This disclosure document (“Disclosure Document”) summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you, sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however that no government agency has verified the information contained in this document.**
