The franchised business is a restaurant business serving breakfast, lunch and dinner during the hours of 6:00 A.M. to 10:00 P.M. in Los Angeles.

The total investment necessary to begin operation of a "Perko's Café & Grill" franchise is between \$555,000 and \$735,750. This includes \$35,000 that must be paid to the franchisor or affiliate.
