As a franchisee, you will operate a business specializing in cleaning, staining and sealing indoor and outdoor surfaces, including, but not limited to granite, tile, stone, pavers, wood and concrete using our process and products, under the name "Perma Treat."

The total investment necessary to begin operation of a Perma Treat® franchise is between \$41,400 and \$73,150. This includes between \$21,500 and \$22,500 that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your Franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
