You will operate a business as pervious concrete contractor. You will offer and sell the placement of pervious concrete and be qualified for any contract specification that requires the use of NRMCA certified personnel. You will provide the services and products operating under the Marks and using the System.

The total investment necessary to begin operation of a Pervious Pros franchised business is from \$29,500 to \$52,000. This includes an initial fee of \$20,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

- 3. WE DO NOT HAVE A FEDERAL REGISTRATION FOR OUR PRIMARY TRADEMARK BUT IT HAS BEEN APPLIED FOR. (SEE ITEM 13)
- 4. THE FRANCHISEES AND THEIR SPOUSES MUST SIGN A GUARANTY AND ASSUMPTION OF OBLIGATIONS MAKING THE FRANCHISEES AND THEIR SPOUSES JOINTLY AND SEVERALLY LIABLE FOR THE OBLIGATIONS UNDER THE FRANCHISE AGREEMENT. THIS REQUIREMENT PLACES THE PERSONAL ASSETS OF THE FRANCHISEES AND THEIR SPOUSES AT RISK.
- 5. WE ARE A NEW FRANCHISE SYSTEM AND HAVE NOT OFFERED FRANCHISES PRIOR TO THE EFFECTIVE DATE OF THIS DISCLOSURE DOCUMENT.
- 6. WE HAVE LIMITED CAPITAL RESOURCES. SEE THE FRANCHISOR'S FINANCIAL STATEMENTS FOR DETAILS. THIS COULD RESULT IN THE FRANCHISOR BEING UNABLE TO MEET CURRENT OBLIGATIONS.
- 7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
