<u>Retail Pet Store Program</u> The total investment necessary to begin operations of one Pet Depot® retail store ranges from \$272,550 to \$580,200 This amount includes \$43,000 to \$44,700 that must be paid to the franchisor or an affiliate

<u>Animal Hospital Program</u> The total investment necessary to begin operations of one Pet Depot® Animal Hospital ranges from \$203,950 to \$612,200 This amount includes \$43,000 to \$44,700 that must be paid to the franchisor or an affiliate

<u>Combined\_Retail Pet Store/Animal Hospital Program</u> The total investment necessary to begin operations of one combined Pet Depot® retail store and animal hospital at the same location ranges from \$380,000 to \$1,022,700 This amount includes \$53,000 to \$54,700 that must be paid to the franchisor or an affiliate

**Boutique Retail Pet Store Program** The total investment necessary to begin operations of one Pet Depot® Barkery retail store ranges from \$110,550 to \$252,200 This amount includes \$23,000 to \$26,700 that must be paid to the franchisor or an affiliate
