The franchisee will operate a single, full-service, basketball-focused fitness club under the name PickUp USA Fitness®. PickUp USA Fitness clubs offer members access to traditional cardiovascular and strength training exercise equipment, combined with staff-organized and officiated pick-up basketball games structured to maximize playing time for members. PickUp USA Fitness clubs also offer group and private basketball training programs, as well as lounges, locker rooms, and retail merchandise areas.

The total initial investment necessary to begin operation of the franchised business ranges from \$337,266 to \$794,054. This includes \$30,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
