The franchise offered is to operate a Pieology quick service restaurant selling pizza and other food products and services.

The total investment necessary to begin operation of a Pieology Restaurant franchise ranges from \$458,500-\$839,500. This includes \$35,000 that must be paid to the franchisor or affiliate.

If you sign a Development Rights Rider, your initial investment will vary depending on the number of Restaurants you want to open. The Development Fee is \$10,000 multiplied by the minimum number of Restaurants that you agree to develop under the Schedule, plus a \$35,000 initial franchise fee (which includes \$10,000 to cover training costs) under each of those franchise agreements.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN CALIFORNIA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.

2. THE FRANCHISE AGREEMENT STATES THAT CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

3. WE MAY MODIFY YOUR TERRITORIAL EXCLUSIVITY IF YOU DEFAULT ON ANY OF YOUR OBLIGATIONS UNDER THE FRANCHISE AGREEMENT.
