The Franchisee will operate a pizza and pasta restaurant which offers both sit-down and take-out service and may include delivery service. The total investment necessary to begin operation of a Pizza Factory Franchise ranges from \$137,500.00 - \$426,000.00 for a Pizza Factory - Full-Size, \$111,700.00 - \$249,400.00 for a Pizza Factory - Mid-Size and \$85,700.00 - \$187,900.00 for a Pizza Factory Express. These estimates include an initial payment of between \$24,750.00 - \$25,850.00 to establish a Pizza Factory franchise restaurant that must be paid to Pizza Factory or its affiliate(s). The Franchisee applicant shall pay a fee for a consultation and market feasibility study of \$7,500.00 which shall be applied towards the above-mentioned initial payment in the event that the applicant is accepted and enters into the Franchise Agreement.

The estimated initial investment required may vary, or even exceed this estimate, depending upon the cost of tenant improvements. Also, this sum does not include rent for the business location.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and accompanying Agreements carefully. **Note, however, that no government agency has verified the information contained in this Document.** You must receive this Disclosure Document at least fourteen (14) calendar-days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed Franchise sale.

The terms of your contract will govern your Franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant. Buying a Franchise is a complex investment.
