If you pursue an Area Representative opportunity, you will operate a single unit Planet Beach Spa franchise and sell additional franchises to others in your territory. As a franchisee, you will operate a Planet Beach location that offers tanning and spa services. You will sell tanning, spa and skin care products, apparel and other specialty items under the name "Planet Beach". The total investment necessary to begin operation of a Planet Beach franchise is from \$201,850 to \$394,550. This includes \$30,000 that must be paid to the franchisor, plus up to \$144,000 for equipment, up to \$6,800 for computer and software, up to \$11,050 for shipping, handling and set-up of the equipment, up to \$2,000 for a timer system, up to \$7,500 for wholesale goods and \$2,500 for construction drawings that you will pay to us before opening your Spa.

In addition, you will be a development agent and sell Planet Beach Spa franchises. You will be offered this opportunity to market individual states or large geographical or population areas. The development price is .10 cents per capita in your development territory. Territories that have preexisting and/or awarded licenses are subject to additional fees. The estimated total initial investment for an Area Representative ranges from \$58,700.00 to \$73,950.00 exclusive of the costs for your single unit spa.

Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
