Planet Nutrition, Inc., a Louisiana Corporation, offers these rights.

You must sign a franchise agreement. We expect you to have substantial prior business, sales and/or service operations experience. The franchisee fee is \$30,000.00. We estimate the initial investment required, including the franchise fee to establish a Planet Nutrition establishment to range from \$161,000.00 to \$341,500.00 inclusive of leasehold improvements and excluding Real Estate, and Construction of Building on Leased Ground.

Risk factors to consider:

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO MEDIATE AND/OR ARBITRATE WITH US, ONLY IN LOUISIANA.
- 2. THE FRANCHISE AGREEMENT STATES THAT LOUISIANA LAW GOVERNS THE AGREEMENT.
