The franchise is to operate a retail food business under the TASTI D-LITE® and/or PLANET SMOOTHIE® names (a "Planet Tasti Center") that utilizes a distinctive store design and business format to sell a wide variety of products, including a proprietary frozen dairy dessert, toppings, mix-ins (fresh fruit and dry), smoothies, shakes, parfaits, frozen cakes and pies, confections, baked goods and other novelties within a customer service-oriented environment to appeal to health conscious consumers. The area developer business is for the right to develop, market franchises for, and service Planet Tasti Centers.

The total investment necessary to begin operation of a Planet Tasti Center is \$91,600 to \$408,360 depending on the franchise design model you will operate (Traditional Planet Smoothie, Traditional Planet-Tasti, Non-Traditional Tasti D-Lite or Non-Traditional Planet Smoothie). This includes \$22,500 to \$40,600 that must be paid to the franchisor or its affiliate (excluding possible discounts applicable under the VetFran or Minority Fran programs). If you sign an agreement for multi-unit development, then you must pay the franchisor or its affiliate \$10,000 times the number of additional Planet Tasti Center outlets you agree to develop. The total investment necessary to begin operation of an area developer business is \$167,250 to \$1,045,100. This includes \$150,000 to \$1,000,000 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
