The franchisee will operate a PLAYlive Nation premium social gaming lounge.

We offer two programs:

**Single Unit Program:** The total investment necessary to begin operation of a PLAYlive Nation premium social gaming lounge franchised business ranges from \$147,660 to \$264,140. This includes the initial franchise fee of \$45,000 that must be paid to the franchisor or its affiliate(s).

Multi-Unit Program: The total investment necessary to begin operations of a PLAYlive Nation premium social gaming lounge franchised business ranges from \$243,660 to \$384,140 (a minimum of two to six but can be more if you are qualified to develop more than six PLAYlive Nation premium social gaming lounge). The initial development fee ranges from \$26,500 (to develop one additional franchise) to \$132,500 (to develop five additional franchises).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale or grant.
