## **PLUMBING DOCTOR®**

As a franchisee you will offer plumbing service and repair and sewer and drain cleaning services

Currently, the initial standard franchise fee is \$20,000. These fees assume a territory of standard size. A standard size territory is any territory with a population of up to 150,000 people. For territories in which the population exceeds 150,000 people, the fee is increased by \$100 per additional 2000 people.

The total investment necessary to begin operation of a Plumbing Doctor franchise is \$24,500 to \$59,300. This includes \$20,000 that must be paid to the franchisor, Fast Aid Success Systems.

As of September 2012, Fast Aid Success Systems, selling the Plumbing Doctor franchise system, is a member of the International Franchise Association and participates in IFA's VetFran Program, which provides special financial incentives to qualified veterans. We offer a discount of 25% off the franchise fee to qualified veterans who were honorably discharged. This discount is subject to change.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **NOTE, HOWEVER, THAT NO GOVERNMENTAL AGENCY HAS VERIFIED THE INFORMATION CONTAINED IN THIS DOCUMENT.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
