The franchise is offered for the rights to operate a Pokeworks franchised restaurant, a retail quick service restaurant selling Hawaiian poké made using high-quality, sustainably sourced fish from local waters and beyond, as well as a variety of related menu items, sushi dishes, beverages, and other items using the trademark POKÉWORKS™.

The total investment necessary to begin operation of a Pokeworks franchised restaurant ranges between \$225,500 and \$800,500, including \$30,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Pokeworks franchised restaurant under a Multiple Unit Development Agreement ranges between \$215,500 and \$800,500, including \$20,000 to \$30,000 that must be paid to the franchisor or its affiliates.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 days before you sign a binding agreement or make any payment in connection with the franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
