The Business you will own and operate is acting as our Area Representative by offering and selling Poki Bowl Franchises and Area Development Rights and acting as our designated servicing agent of the Poki Bowl® Franchise Businesses you sell within a specific Service Area ("Area Representative Rights") You are also required to open and have in operation, your own Poki Bowl franchise unit You must also purchase a Franchised Unit we offer by a separate Franchise Disclosure Document for the sale of Franchises and Area Development Rights

The total investment necessary to purchase Area Representative Rights is equal to \$17,500 times the number of Franchised Units to be developed, which must be paid to us or our affiliate The total initial investment necessary for a single Poki Bowl® Center ranges from \$169,750 - \$326,500 This includes a \$35,000 initial franchise fee that must be paid to us You must also purchase a booth for trade shows, registration fees and marketing materials from third party vendors for approximately \$5,000
