You will operate a quick-service restaurant specializing in the sale of fried chicken, seafood and other quick service food under the name "Popeyes Louisiana Kitchen" ("Restaurant")

The total investment necessary to begin operation of a Popeyes Louisiana Kitchen franchised business is between \$945,515 to \$1,685,363 for a new free-standing facility, between \$601,840 to \$911,707 for a new in-line facility, and between \$695,257 to \$1,140,216 for a converted facility, excluding real estate This includes a franchise fee for each Restaurant of \$22,500 and a development fee of \$22,500 that must be paid to us. You may be eligible to sign a Development Agreement to develop more than one Restaurant pursuant to a Development Schedule, in which case you will pay a development fee in the amount of \$22,500 for each Restaurant that you commit to develop

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or our affiliate in connection with the proposed sale. Note, however that no governmental agency has verified the information contained in this document.
