On behalf of our client, **Blue Stamp Franchise Company** ("BSF"), doing business as Postal Connections of America (**File No. 993-6910/490936**) and in response to your comments regarding BSF's pending franchise registration in California, please consider the following

1 In response to your first comment, BSF elects to defer payment of the franchise fee until it fulfills its pre-opening obligations to each California franchisee. We modified Items 5 and 7 of BSF's franchise disclosure document ("FDD") and Section 3.1 of the Franchise Agreement accordingly.

2 In response to your second comment, we modified the Cover Page of the FDD accordingly.

3 In response to your third comment, when BSF's predecessor Templar Franchise Company ("TFC") acquired the Postal Connections marks and franchise system from another predecessor and commonly owned entity, Postal Connections of America Franchise Corp ("PCAFC") on January 23, 2007 (more than six years ago), PCAFC had a total of 68 unit franchises (of which 19 were in California) and 8 area developer franchises (of which one was located in California). BSF does not have a copy of an order of registration respecting PCAFC that was effective at the time of sale (again this occurred more than six years ago) but attached is a copy of the order granting registration to TFC on March 19, 2007.


4 In response to your fourth comment, we modified Item 20 of the FDD accordingly.

5 In response to your fifth comment, we modified the List of Administrators (Exhibit G) of the FDD accordingly.

6 I previously responded to your sixth comment and again request that you remove the erroneously submitted LinkedIn message from the file.

Enclosed are (i) copies of all revised pages of the FDD (marked to show changes) and (ii) clean copies of the entire parts of the FDD that were revised. Please review these enclosures and notify us when the registration is granted or of any questions that you may have.


