PCJV USA, LLC, a California limited liability company, offers franchises for the operation of Potato Corner Restaurants ("**Potato Corner Restaurants**") that offer flavored french fries, baked potatoes, hash browns, loopy fries, chicken tenders and related food and beverage products. We offer the rights for 2 different franchises in this Disclosure Document:

<u>Single Restaurant Program</u>. Under the Single Restaurant Program, you will sign a Franchise Agreement for a single Potato Corner Restaurant. The total investment necessary to begin operation of a single Potato Corner Restaurant ranges from \$134,100 - \$359,450. This includes \$31,000 to \$35,250 that must be paid to the franchisor or an affiliate.

<u>Area Development Program</u>. Under the Area Development Program, we assign a defined area within which you must develop and open a minimum of 2 to 10 Potato Corner Restaurants within a specified period of time. The total investment necessary to begin operation under an Area Development Agreement is \$167,100 – \$394,450 for developing 2 to 10 Restaurants. This includes \$61,000 to \$65,250 that must be paid to the franchisor or an affiliate.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read the Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payments to the Franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

4. OUR AFFILIATE, PC TRADING, LLC, IS THE SOLE SOURCE FOR CERTAIN FOOD PRODUCTS AND SUPPLIES. PC TRADING, LLC HAS ABSOLUTE POWER TO SET THE PRICES IT CHARGES FOR FOOD PRODUCTS AND SUPPLIES.

5. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISE FAILS.

6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A FRANCHISE BROKER or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
