Primrose School Franchising Company dba Primrose Schools ("PSFC") offers franchises for the establishment, development, and operation of facilities operating under the Primrose Schools mark, which provide learning and educational oriented activities, including child care services, to children from six weeks to twelve years old (each, a "Facility").

The total investment necessary to begin ownership of a PRIMROSE franchise ranges from \$2,830,7003,457,075 to \$4,490,5004,634,175 assuming your real estate affiliate purchases the premises for your Facility (using the Real Estate Affiliate Development Program). This includes approximately \$149,500 that must be paid to PSFC. Should you choose to lease the Facility from a developer or independent third party unaffiliated with you, the total investment necessary to begin ownership of a PRIMROSE franchise ranges from \$637,275663,575 to \$2,784,1752,914,175 (using the Developer Lease Program, Build-to-Suit Program or Permanent Lease Program). This includes approximately \$115,000 to \$230,000 that must be paid to PSFC. Should you have extensive real estate development and construction experience and we permit you to develop the Facility without any assistance from us, the total investment necessary to begin ownership of a PRIMROSE franchise ranges from \$2,796,200 - \$4,466,0003,612,575 to \$4,649,675 (using the Independent Development Program). This includes approximately \$115,000 that must be paid to PSFC. These different Programs for the development of a Facility are described in more detail in Item 1 of this Disclosure Document.

PSFC may offer you the option to sign an "**Option Addendum**" that will give you the option to develop additional Facilities within a specific geographic area during a specified development period. When you sign the Option Addendum, you must pay PSFC an option fee of \$20,000 for each additional Facility that can be developed under the Option Addendum, and upon exercising each option, you must pay PSFC its then-current initial franchise fee minus the portion of the option fee paid for the option on the Facility.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document**.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read your entire contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind.
