

The franchise renewal application for the above-referenced franchisor has been examined. Please correct or otherwise address the following deficiencies:

1. Please refer to the Consent to Service of Process. The document is missing the actual date / day that the document was signed.
2. Please refer to the Auditors Consent document. The document must be on the accountant's letterhead.
3. Please submit the franchisor's auditor's financial statements. The version that we received appears to have several pages missing including the balance sheet.
4. Please refer to Item 21: Please submit a 90-day updated balance sheet and income statement. See Minn. Stat. 80C.04 (g). Amend Item 21 to disclose the financials. These documents do not have to be audited.

In responding to the above deficiencies, submit only the marked pages (one set). Do not send the copy. If additional changes have been requested from other states please include only the pages showing those corrections also.

Please email us the revised document(s). Please note: The Commissioner may withdraw an application in which no activity has occurred for 120 days (Minnesota Statute § 80C.05, Subd. 4). If an Order of Withdrawal is issued, the franchisor must reapply with a new application.
