This business provides professional real estate services with the flexibility in service offerings in order to accommodate each demographic area.

The total estimated initial investment required to begin operation of a Prospect Equities® Franchise ranges from \$43,900 to \$ 100,500 which will depend on a number of factors that are fully discussed in Item 7. This includes the Initial Franchise Fee of \$15,000 (as discussed in Item5) that must be paid to the franchisor or affiliate.
