The Franchise we offer is for the operation of a fully mobile pet grooming business under the name Puparazzi Mobile Pet Spaw from a specified location and featuring services and products that we authorize or develop from time to time

The total estimated investment necessary to begin operation of a single Puparazzi Mobile Pet Spaw franchise ranges from \$57,528 to \$84,249 This includes the initial Franchise fee of \$37,500 that must be paid to us (See Items 5 and 7 for additional information) At the time of signing, and with our approval, you may purchase an additional contiguous territory containing a population of 40,000 people for an additional fee of \$18,750, and further additional contiguous territory of up to 500,000 persons for an additional fee of 08 per person
