Radisson RED

The franchise offered is for the right to operate a hotel that provides lodging services to the public in the upscale select service segment under the name "Radisson RED®."

The total investment necessary to begin operation of a newly constructed 126-room Radisson RED Hotel is typically between \$16,174,000 and \$24,120,500, but excludes the cost of real estate. The total investment necessary to begin operation of a 126-room Radisson RED® conversion Hotel is typically between \$1,924,000 and \$12,280,500. These amounts include \$81,200 to \$85,700 that must be paid to the franchisor or its affiliates.

This Disclosure Document summarizes certain provisions of your License Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
