As a franchisee, you will operate a retail store offering home décor, furniture, home accessory, jewelry, clothing, personal accessories, food and beverage items, and other related merchandise and products.

The total investment necessary to begin operation of a Real Deals on Home Décor® franchise is between \$140,600 - \$229,200. This includes the \$32,000 - \$36,000 that must be paid to the franchisor or affiliate.

- 3. YOU MUST MAINTAIN MINIMUM SALES PERFORMANCE LEVELS. IF YOU FAIL TO DO SO, YOU COULD LOSE YOUR EXCLUSIVE TERRITORY OR THE FRANCHISOR COULD TERMINATE YOUR AGREEMENT AND YOU COULD LOSE YOUR INVESTMENT.
