Rebounderz Franchise and Development, Inc. offers franchises for the operation of a family entertainment, recreation and party facility that offers groups and individuals a large, fun environment featuring an arena-style jumping court, video arcade, Wi-Fi café, lounge and related programs and services.

The total investment necessary to begin operation of a Rebounderz franchise ranges from \$1,~~233,257~~279,457 to \$2,~~282,177~~926,377. This includes \$845,457 to \$1,~~247~~838,377 that must be paid to us and our affiliates.

If you sign an area development agreement to open multiple Rebounderz facilities, the total investment necessary to begin operating your Rebounderz franchise ranges from \$1,274,457 to \$2,926,377, plus an additional \$20,000 for each additional Rebounderz facility you commit to open under your area development agreement (other than your first facility). This includes \$853,457 to \$1,838,377, plus an additional \$20,000 for each additional Rebounderz facility you commit to open under your area development agreement, that must be paid to us.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
