The franchise offered is for the operation of a granite and stone recycling business that re-purposes granite and stone remnants by turning them into different size products and selling them to architects, builders, contractors and homeowners for construction and remodeling projects. This is a “green” environmentally-friendly business that eliminates landfill waste, saves energy, makes products using proprietary equipment and creates jobs, under the name “Recycled Granite™”. The Initial Franchise Fee is \$25,000 to complement an existing business with a Recycled Granite™ business (Model A, B, or C) with protected rights to operate in a specific area as defined by us. Additional franchises may be available for those franchisees who have bought at least one franchise, at a reduced fee of \$15,000 per Franchise. The total investment necessary to begin operation of a Recycled Granite™ franchise ranges from \$35,000 to \$49,275 for a Model A, from \$60,700 to \$83,775 for a Model B, and from \$102,700 to \$130,775 for a Model C, which will depend on a number of factors which are further discussed in Item 7. These figures include the Initial Franchise Fee of \$25,000 for any Model (A, B, or C) (as discussed in Item 5) that must be paid to the Franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read the disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale. **Note, however, no governmental agency has verified the information contained in this document.**
