The franchise offered by Red Boy Pizza Franchising Corp is for the right to establish and operate a Red Boy Pizza Restaurant

The total initial investment required to commence operations of a Red Boy Pizza franchise is estimated to range from \$186,000 to \$270,000 for a take-out Red Boy Pizza and \$279,000 to \$407,000 for a sit-down Red Boy Pizza restaurant. This includes the initial franchise fee of \$15,000 and the pre-opening services fee of \$10,000. The initial franchise fee for any subsequent franchise purchased by an existing franchisee is \$10,000.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
