The franchise offered in this disclosure document is for the rights to own and/or operate a Red Lion hotel business.

The total investment necessary to begin operation of an 80 room Red Lion Inn & Suites franchise with a minimal food and beverage offering is estimated to range between \$7,090,250 to \$10,998,000 for new development and \$587,750 to \$1,380,500 for conversion hotels including the product improvement plan fee of \$2,500 that must be paid to the franchisor. These amounts also include an affiliation fee of \$40,000 paid to the franchisor. These amounts do not include the cost of purchasing or leasing land or any real estate taxes.

The total investment necessary to begin operation of a 250 room full service Red Lion Hotel franchise, including meeting space and catering service, is estimated to range between \$26,806,250 to \$37,093,000 for new development and \$777,750 to \$1,585,500 for conversion hotels, including the product improvement plan fee of \$2,500 that must be paid to the franchisor. In the case of new development and conversion hotels, these amounts include an affiliation fee of \$75,000 that must be paid to the franchisor. These



amounts do not include the cost of purchasing or leasing land or any real estate taxes.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you. - 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY MEDIATION AND ARBITRATION ONLY IN SPOKANE, WASHINGTON. OUT-OF-STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE AND ARBITRATE WITH US IN WASHINGTON THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT WASHINGTON LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
