We offer two types of franchises 1) a single Location franchise(s), and 2) a Regional Developer franchise(s) Note that the term "Regional Developer" as used in this document has the same definition and meaning as an 'Area Representatives" under the new NASAA Multi-Unit Commentary adopted in September 2014 Each Location franchise will conduct business under the name of "RedLine Athletics®", "RedLine® Youth Athletic Training Centers", and/or "RedLine®", and will operate a training center that provides sports performance training products and services to the public, with a focus on ages 8 through 18 Regional Developers will recruit prospective Location franchises in a defined Development Area, and provide certain sales and support services to the Location franchises located within the Development Area. We are offering the right to operate a Location franchise under this Disclosure Document Regional Developer franchises are offered under our separate disclosure document for Regional Developers

The estimated total initial investment necessary to begin operations of your Location franchise will range from \$188,275 to \$270,525. This amount includes an Initial Franchise Fee of \$39,000 that must be paid to the franchisor or an affiliate.

This disclosure document ("Disclosure Document") summarizes certain provisions of your franchise agreement and other information in plain English Read this Disclosure Document and all accompanying agreements carefully You must receive this Disclosure Document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document
