The franchise offered is for the operation of a franchised store under the mark "THE ORIGINAL RED'S SAVOY PIZZATM", which makes and sells pizza and related items for dine-in, delivery and carryout using the Franchisor's recipes, formulas, business policies, trademarks, service marks and trade names.

The total investment necessary to begin operation of a RED'S SAVOY PIZZATM store is between approximately \$200,500 to \$347,167, depending upon the size of the operation, whether you purchase or lease your equipment, and the market in which the store is located. This range includes approximately \$18,500 to \$21,500 that must be paid to the Franchisor.

The Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
