The franchisee will operate a Regal Nails Salon & Spa[®] location, a modern, high style nail salon in a shopping center.

The total investment necessary to begin operation of a typical Regal Nails Salon & Spa franchise is from \$170,525 to \$748,470. This includes \$171,940 to \$654,073 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. - 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN BATON ROUGE, LOUISIANA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN BATON ROUGE, LOUISIANA THAN IN YOUR HOME STATE. FOR SOME LEASE RELATED MATTERS YOU ARE REQUIRED TO RESOLVE DISPUTES WITH US BY LITIGATION ONLY IN BENTON COUNTY, ARKANSAS. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO SUE US IN BENTON COUNTY, ARKANSAS THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT LOUISIANA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS. THE MASTER LEASE AGREEMENT STATES THAT ARKANSAS LAW (EXCLUDING THE LAW REGARDING CONFLICT OF LAW) GOVERNS THAT AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. OUR BUSINESS MODEL AND YOUR ABILITY TO OPERATE YOUR FRANCHISED BUSINESS DEPEND ON OUR ABILITY TO MAINTAIN A MASTER LEASE AGREEMENT FOR SALON FACILITIES. IF OUR MASTER LEASE AGREEMENT ENDS (IN TOTAL OR FOR YOUR SPECIFIC LOCATION) FOR ANY REASON, YOUR FRANCHISE AGREEMENT ALSO ENDS, AND WE HAVE NO LIABILITY TO YOU.
- 4. THE FRANCHISOR IS A GUARANTOR TO A PERSONAL \$3,000,000 LOAN OF THE MANAGING MEMBER AND HIS WIFE. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE.
- 5. THE TERRITORY IS NOT EXCLUSIVE. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM FRANCHISOR OWNED OUTLETS OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS FRANCHISOR CONTROLS.
- 6. THE FRANCHISE AGREEMENT CONTAINS PROVISIONS THAT LIMIT FRANCHISEE'S RIGHTS AND MAY NOT BE ENFORCEABLE IN CALIFORNIA, INCLUDING, BUT NOT



LIMITED TO, A TIME LIMIT TO RAISE CLAIMS AGAINST THE FRANCHISOR, LIMITATION OF DAMAGES AND WAIVER OF JURY TRIAL.
