The franchise being offered is for the right to operate a retail store featuring back-related equipment, furniture and products that we approve under the trade name “RELAX THE BACK®.”

The total investment necessary to begin operation of a single RELAX THE BACK Store is \$205,700 to \$372,125. This includes \$35,500 to \$47,250 that must be paid to the franchisor or its affiliate(s).

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

1. **THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION OR LITIGATION ONLY IN CALIFORNIA. OUT-OF-STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE OR LITIGATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.**
2. **THE FRANCHISE AGREEMENT STATES THAT DELAWARE LAW GOVERNS THESE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.**
3. **FRANCHISEE WILL NOT RECEIVE AN EXCLUSIVE TERRITORY AND MAY FACE COMPETITION FROM FRANCHISOR, OTHER FRANCHISEES OR OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS CONTROLLED BY FRANCHISOR.**
4. **BEGINNING 24 MONTHS AFTER THE DATE OF THE FRANCHISE AGREEMENT, FRANCHISEE IS SUBJECT TO A “CORRECTION PROCESS” IF FRANCHISEE’S FINANCIAL STATEMENTS ARE NOT ABOVE A SPECIFIED LEVEL. IF YOU HAVE FAILED TO MEET THE STANDARDS AND DO NOT ADVISE US OF YOUR WISH TO SELL TO A THIRD PARTY, WE HAVE THE RIGHT TO TERMINATE YOUR RIGHTS UNDER THE FRANCHISE AGREEMENT OR WE MAY REDUCE, ELIMINATE OR OTHERWISE MODIFY YOUR TERRITORIAL AND SIMILAR RIGHTS.**
5. **THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
