The franchisee will establish and operate a full-service hotel under the name “Renaissance Hotel,” “Renaissance Resort,” “Renaissance ClubSport,” or “Renaissance Hotel & Conference Center.”

The total investment necessary to begin operation of a newly-constructed 300-guestroom Renaissance Hotel, excluding the cost of land and building permit, tap, and impact fees, ranges from \$62,660,340 to \$94,313,540 and from \$65,747,130 to \$98,521,230 for a newly-constructed 200-guestroom Renaissance ClubSport. This includes approximately \$439,850 to \$531,450 that must be paid to the franchisor or an affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
