The franchise described in this Disclosure Document is for a business that sells solar photovoltaic products and solutions to businesses on a wholesale basis for resale and on a retail basis directly to commercial and residential consumers, with rights to offer subfranchises for this business. The total investment necessary to begin operation of a RERi PV.tv franchise is \$389,000 - \$431,000. This includes \$350,000 that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
