RETAIN, LLC offers franchises for the sale of customer loyalty and retention products and services. Customers for the products and services are automobile dealers and other motor vehicle related businesses for which ongoing contact with current and previous customers is the key to developing repeat business.

The total estimated initial investment required for a RETAIN franchise ranges from \$34,650 to \$43,250. This includes the Initial Franchise Fee of \$29,000 that must be paid to the Franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or any affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
