The franchise is to operate an investment management services business under the trade name “Retirement Income Store”.

The total investment necessary to begin operation of a Retirement Income Store franchise is \$101,400 to \$228,500. This includes \$25,000 that must be paid to the franchisor or affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
