The franchise described in this disclosure document is for the operation of a RevoluSun® business, which offers design and build services for photovoltaic solar energy systems

The total investment necessary to begin operation of a RevoluSun franchise is \$164,810 to \$532,970. These ranges include an Initial Franchise Fee of \$50,000. The Initial Franchise Fee must be paid to the Franchisor, RevoluSun Solar Corp.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
