River Street Candy Kitchen, LLC d/b/a “River Street Sweets Savannah’s Candy Kitchen” (“RSCK”) offers franchises for the operation of specialty handmade candy and confectionary stores under the mark RIVER STREET SWEETS SAVANNAH’S CANDY KITCHEN and other marks using a proprietary system of operations (“Stores”).

The total investment necessary to begin operation of a RSCK franchise is from \$396,800 to \$811,850. This includes an initial franchise fee of \$40,000 (if this is your first Store; \$30,000 for veterans) or \$24,000 (if you already have a Store) that must be paid to the franchisor or affiliate. If you sign an Area Development Agreement, you must pay us a development fee equal to \$12,000 for each additional Store that you agree to develop. \$12,000 of the development fee will be credited towards the initial franchise fees for each additional Store as described in the Area Development Agreement.

This Franchise Disclosure Document (“Disclosure Document”) summarizes certain provisions of your Franchise Agreement, Area Development Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or its affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient for you. The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read your entire contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.
