We are offering a franchise for a retail store operating under the “Rent-n-Roll” and “RNR Custom Wheels & Tires” names that sell and rent wheels, tires and other automotive accessories.

The total investment necessary to begin operation of a new RNR Custom Wheels & Tires Store is \$288,795 to \$563,475. This includes \$27,500 that must be paid to the franchisor or its affiliate.

We may also offer a multi-unit development agreement to an individual or company that agrees to develop at least three RNR Custom Wheels & Tires stores in a specific geographic area. A multi-unit developer will pay a development fee that is equal to 100% of the initial franchise fee for the first store to be developed, plus a deposit equal to 50% of the reduced initial franchise fee for each additional store that will be developed. We will apply a pro rata portion of the development fee toward the initial franchise fee due for each store, and the balance of the reduced initial franchise fee is payable by you when you sign the Franchise Agreement for each store. The total investment necessary under the multi-unit development agreement will vary depending on the number of stores to be developed.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE MEDIATION AND ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO MEDIATE OR ARBITRATE WITH US IN FLORIDA THAN IN YOUR OWN STATE.
