The franchise offered is for the establishment and operation of a specialty coffee shop with a rock-and-roll motif that offers a variety of specialty coffee drinks, sandwiches, soups and salads, side items, desserts, and other food and beverage items. You must operate the franchised business according to our standards and specifications.

The total investment necessary to begin operation of a Rock N Joe franchise is \$228,500 to \$415,000. This includes the \$30,000 Franchise Fee you must pay us. This does not include a \$7,500 per location option fee for each additional location should you choose to reserve the right to open more than one location by executing a Multi-Unit Option Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

OUT OF STATE ARBITRATION OR LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE OR LITIGATE WITH US IN PENNSYLVANIA THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT PENNSYLVANIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 4. THE FRANCHISEE WILL BE REQUIRED TO MAKE AN ESTIMATED INTITAL INVESTMENT RANGING FROM \$228,500 to \$415,000. THIS AMOUNT EXCEEDS THE FRANCHISOR'S STOCKHOLDER EQUITY AS OF DECEMBER 27, 2015, WHICH IS (\$9133).
- 3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
- 4. PLEASE NOTE THAT 76% OF FRANCHISOR'S ASSETS ARE INTANGIBLE.
