The franchised business is to operate a state-of-the-art group fitness studio under the trade name “RockBox Fitness”.

The total investment necessary to begin operation of a RockBox Fitness franchise is \$169,450 to \$258,300. This includes \$91,700 to \$93,400 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation under a three- to five-unit Multi-Unit Development Agreement is \$492,350 to \$1,259,500. This includes \$209,900 to \$285,000 that must be paid to us. There is no minimum number of RockBox Fitness units that you are required to develop under the Multi-Unit Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don’t rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.
