The franchised business is to operate a membership-based state-of-the-art group fitness studio under the trade name "RockBox Fitness" that offers functional fitness training regimens for a boxing and kickboxing based workout (each, a "Studio").

The total investment necessary to begin operation of a single Studio is  $\frac{234,993252,292}{252,292}$  to  $\frac{463,900588,206}{252,206}$ . This includes  $\frac{164,193}{100}$  to  $\frac{178,200131,947}{100}$  that must be paid to us or our affiliate.

We also grant qualified parties the right to develop multiple Studios within a defined geographical area under our form of area development agreement. The total investment necessary to begin operating as a multi-unit owner will vary depending on how many Studios we grant you the right to develop. In any case, the minimum number of Studios we grant a qualified party the right to develop is three (3) Studios. Here are some questions you may be asking about buying a franchise and tips on how to find more information:

QUESTION	WHERE TO FIND INFORMATION
How much can I earn?	Item 19 may give you information about outlet sales, costs, profits or losses. You should also try to obtain this information from others, like current and former franchisees. You can find their names and contact information in Item 20 or Exhibits G and H.
How much will I need to invest?	Items 5 and 6 list fees you will be paying to the franchisor or at the franchisor's direction. Item 7 lists the initial investment to open. Item 8 describes the suppliers you must use.
Does the franchisor have the financial ability to provide support to my business?	Item 21 or Exhibit C includes financial statements. Review these statements carefully.
Is the franchise system stable, growing, or shrinking?	Item 20 summarizes the recent history of the number of company-owned and franchised outlets.
Will my business be the only RockBox business in my area?	Item 12 and the "territory" provisions in the franchise agreement describe whether the franchisor and other franchisees can compete with you.
Does the franchise have a troubled legal history?	Items 3 and 4 tell you whether the franchisor or its management have been involved in material litigation or bankruptcy proceedings.
What's it like to be a RockBox franchisee?	Item 20 or Exhibits G and H list current and former franchisees. You can contact them to ask about their experience.
What else should I know?	These questions are only a few things you should look for. Review all 23 Items and all Exhibits in this disclosure document to better
