

Rockstars of Tomorrow Franchise, Inc. offers franchises for the operation of music schools at converted residences and other specified locations, offering instruction in music (featuring the rock and roll genre) focusing on vocals, guitar, keyboard, and drums, and the retail sale of musical instruments, musical accessories, rock-related collectibles and related merchandise, products and accessories, using designated concepts, designs, recipes, authorized equipment and techniques.

The total investment necessary to begin operation of a Rockstars of Tomorrow single outlet franchise ranges from \$108,700 to \$306,750. This includes \$25,000 to \$35,000 that is paid to the franchisor or affiliate. If you sign an Area Development Agreement, you will be granted the right to open additional Outlets within a negotiated development area under a negotiated development schedule for a development fee paid to Rockstars of Tomorrow Franchise, Inc. of \$17,500 (multiplied by the number of additional Outlets you commit to open).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
