There is one (1) franchise being offered "Rooter-Man" The Rooter-Man franchise features sewer and drain cleaning services which include the maintenance and cleaning of sewer pipes, emergency plumbing repairs and other related services and products Franchises will primarily be sold to individuals who have some experience in providing plumbing, sewer and drain cleaning services

The total estimated initial investment necessary to begin operation of a Rooter-Man franchise ranges from \$46,750 00 to \$137,600 00. The initial franchise fee that will be paid to A Corp is based upon the population of the franchisee's territory. The rate of the franchise fee is \$31.80 per thousand of population, and will generally range from \$3,975.00 to \$39,750.00. A Corp is offering existing and new franchisees a special offer to purchase that if they purchase two (2) units of 125,000 populations, they will receive the third unit for free. The \$125.00 monthly fee will still apply to each of the three units.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
